GST – Are you meeting the governments requirements?



Many clients have asked how to setup Capable so that it provides full support for GST. The steps are very simple. First, you need to be on the latest version. It is best for you to be on version 1.5.47 or above.

Whilst version 1.5.13 supports all the mandatory requirements, you'll find additional features in 1.5.47 that make it much easier to use.

Here are the steps you need to follow:

1. Go to Setup|Settings and turn on GST. Set the GST Rate accordingly (eg 10%).
2. Go to Setup|Stationery design|Receipt Design. Alter your receipt layout to include the mandatory requirements for GST. These are ABN, Clinic Name, Practitioner Name, GST Amount – and the words 'Tax Invoice'.
3. Go to the Setup|Setup Appointment Types and Fees window. Work through each of your fees one at a time. For each fee, you will need to check – the GST percentage, and the price. Capable will not automatically adjust your fees when you turn on GST. You will need to do this yourself.

Its all pretty straightforward. For detailed instructions, contact Dr Chris Hume-Philips and get a copy of his clinic handbook 'Simply Capable'.
